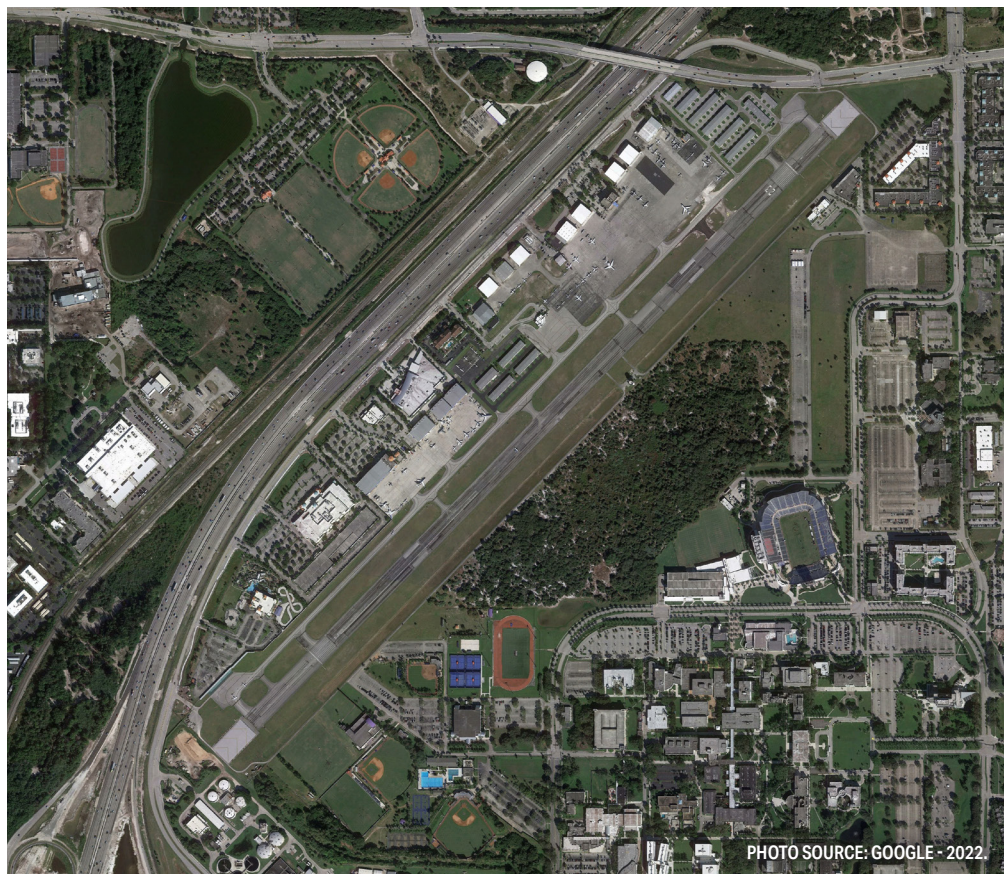
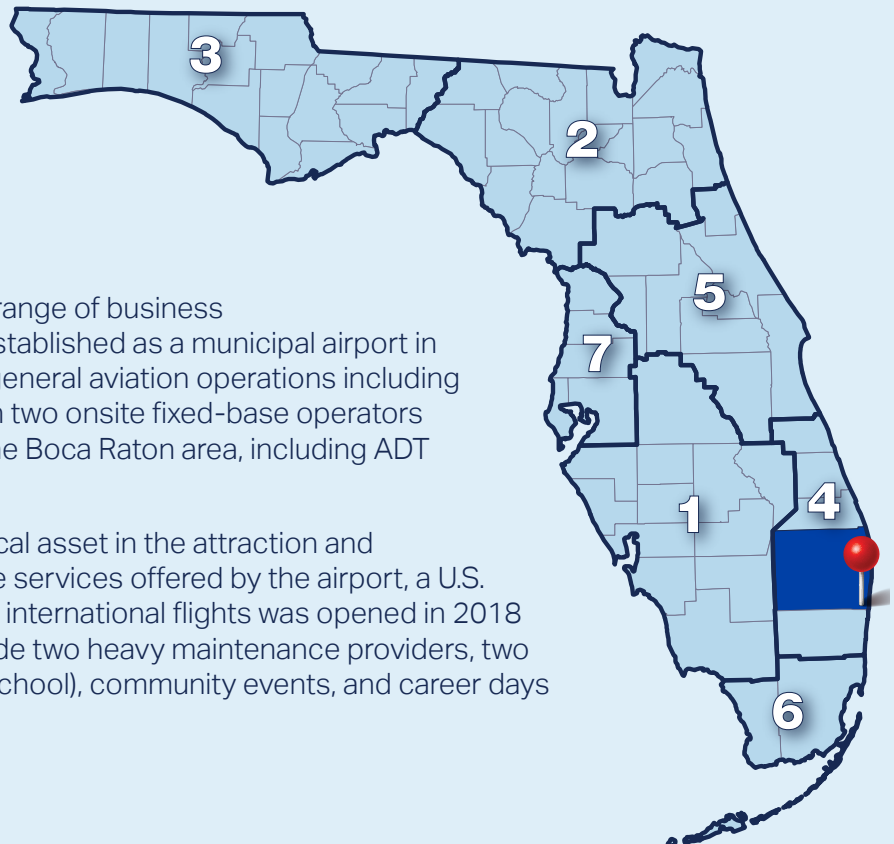

Boca Raton Airport (BCT) is a general aviation Reliever airport in Boca Raton, approximately 18 miles north of Fort Lauderdale and 24 miles south of West Palm Beach. The airport has one paved runway measuring 6,276 feet long by 150 feet wide (Runway 5-23).

The airport can easily accommodate the wide range of business jets that frequently operate at BCT. Originally established as a municipal airport in the 1930s, the airport now primarily supports general aviation operations including business/corporate traffic that operate through two onsite fixed-base operators (FBOs). Major corporations headquartered in the Boca Raton area, including ADT and Office Depot, frequently use the airport.

The City of Boca Raton identifies BCT as a critical asset in the attraction and retention of businesses. To further enhance the services offered by the airport, a U.S. Customs and Border Protection facility to clear international flights was opened in 2018 at BCT. Other activities supported at BCT include two heavy maintenance providers, two flight schools (Lynn University and ATP Flight School), community events, and career days with local high schools.

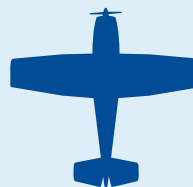

**Overview of the FASP 2043 Update:**

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
