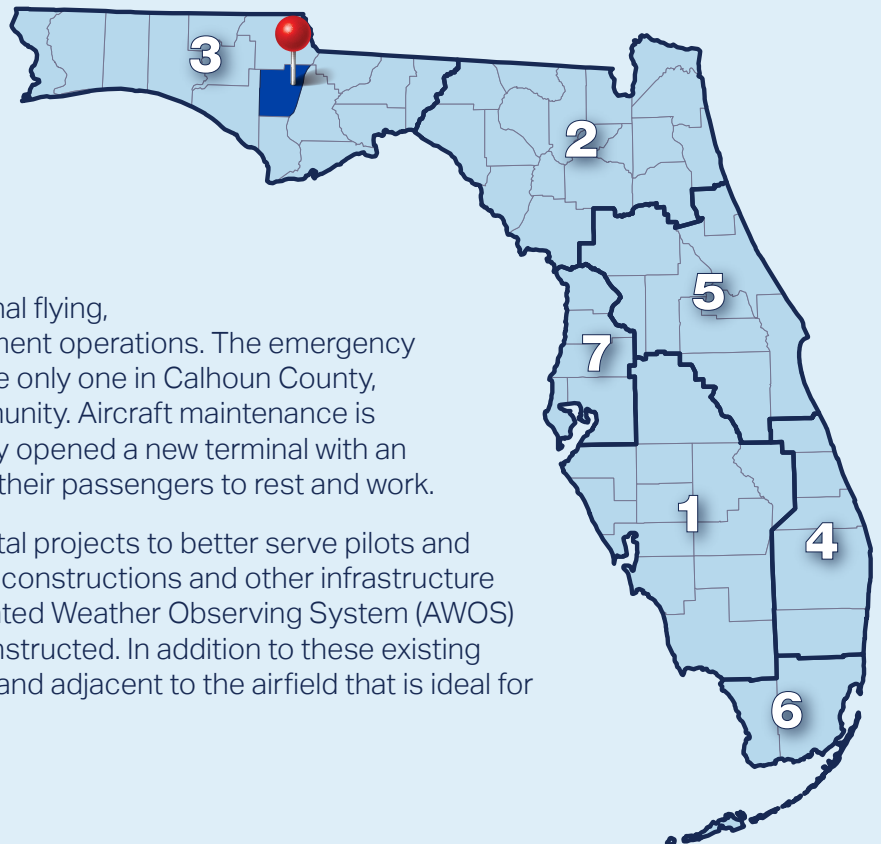

Calhoun County Airport (F95) is a general aviation (GA) airport located west of the Apalachicola River and five miles northwest of Blountstown in the Florida Panhandle. The airport has one asphalt runway that is 3,729 feet long by 75 feet wide (Runway 18-36).

The airport primarily accommodates recreational flying, emergency medical services, and law enforcement operations. The emergency medical service provider operating at F95 is the only one in Calhoun County, making the airport a critical asset for the community. Aircraft maintenance is offered by an onsite tenant. The airport recently opened a new terminal with an attractive pilot's lounge available for pilots and their passengers to rest and work.

The airport recently completed numerous capital projects to better serve pilots and tenant businesses, including multiple hangar reconstructions and other infrastructure improvements. Fiber optic lines and an Automated Weather Observing System (AWOS) critical for helicopter operations have been constructed. In addition to these existing facilities, F95 owns shovel-ready developable land adjacent to the airfield that is ideal for industrial use.

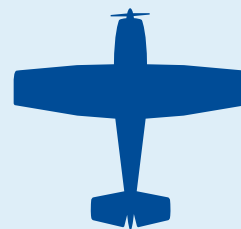

Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
