

Airglades Airport (2IS) is a general aviation (GA) airport located in south-central Florida, approximately equidistant from Fort Myers and West Palm Beach, along State Route 27.

The airport offers a 5,902-foot-long by 70-foot-wide runway (Runway 13-31) frequently used for flight training, agricultural spraying, and operations by Skydive Spaceland. Tenants include Aloft Aviation and Skydive Spaceland.

The airport is currently transitioning to private ownership and shifting its focus to primarily accommodate air cargo and logistics activities. The airport has received authorization to become a designated Port of Entry, and U.S. Customs and Border Protection facilities are being developed adjacent to the recently completed cargo and logistics facilities.

The airport is scheduled to construct a 10,000-foot-long runway to accommodate demanding cargo aircraft, which are forecasted to become more frequent as logistical support facilities are completed. These improvements are anticipated to transform the Airglades Airport into a foundation of trade in south-central Florida.



### Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
