

Jacksonville Executive At Craig Airport (CRG) is centrally located in the Jacksonville metropolitan area and five miles from area beaches including Atlantic, Neptune, Jacksonville, and Ponte Vedra. CRG offers a primary and crosswind runway, the longest of which (Runway 14-32) is 4,008 feet long by 100 feet wide.

CRG is a Reliever for the Jacksonville International Airport (JAX). The airport supports a variety of activities including corporate/ business aviation, flight training, and charter flights. Multiple flight instruction schools offer aspiring aviators the opportunity to receive a private through commercial license with an Airline Transport Pilot (ATP) rating. Jacksonville Executive Jet Center and Sky Harbor Aviation provide comprehensive fixed based operator (FBO) services, including aircraft fuel, maintenance, and storage, line services, and other support for aircraft, pilots, and passengers.

The airport's proximity to downtown Jacksonville and the Mayo Clinic, one of Jacksonville's largest employers, means that CRG supports considerable business activities. Additionally, several recent capital improvement projects have bolstered CRG's ability to serve the aviation community. These include a mill/overlay project on Runway 14-32 and the addition of 3,000 square feet of training, classroom, and administrative space for a flight training tenant.

The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
