

Arcadia Municipal Airport (X06) is a general aviation (GA) airport located in Arcadia. The airport has one paved and one turf runway, the longest of which measures 3,700 feet long by 75 feet wide (paved Runway 6-24). The turf runway (Runway 14-32) is in good condition.

The airport serves a variety of GA activities including recreational flying, aerial agricultural spraying, and flight training. X06 also frequently supports medical air transport, flying patients to medical facilities in Tampa, Ft. Myers, and Sarasota. Recreational fly-ins are common, including a "Taco Tuesday" lunch, offering discounted fuel on Taco Tuesdays, attracting pilots from all over. As well, there is a monthly pancake breakfast held during the winter season. Pilots are often drawn by an FAA approved, on airport campsite. The campsite offers plenty of space for pilots and passengers to enjoy an extended visit to the area.

Aircraft operating at X06 have access to a large apron and self-service fuel available 24 hours a day, seven days a week. In recent years, the airport has seen numerous improvements and additions including airfield lighting, terminal renovations, taxiway enhancements, and a new fixed base operator. Arcadia is known for the beautiful Peace River, antique shopping downtown, and is home to one of the biggest rodeo championships.

## Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
